

PREFACE.

The following pages lay no claim to literary merit, and are merely a collection of facts and information regarding the Regiment, which I have collected from various sources.

I have, unfortunately, been able to discover very little information regarding the Halifax Militia, and have had to rely, for the most part, on old newspaper cuttings and the Militia Lists in the British Museum.

It must be remembered that at the time this force was serving, the Militia was recruited entirely by ballot, and it was not until 1853 that recruits were obtained by voluntary methods, with the exception of the Volunteer Militia companies raised by Act 34, George III. I have to thank Colonel H. J. Johnston, D.S.O., and Captain H. P. Travers, the present Commanding Officer and Adjutant of the Battalion, for giving me free access to the Regimental Records.

Colonel Johnston also, some years ago, compiled a list of officers, with much useful information, which has been of the greatest assistance to me.

My thanks are also due to the following:-

General The Rt. Honourable Sir Dighton Probyn, V.C. (who sent me the photographs of the old colours, at Sandringham), Colonel Gerald Stovell, Lieutenant-Colonel F. A. Hayden, D.S.O. (to whose diary I am greatly

indebted for the account of the services of the Battalion in South Africa), Mr. H. P. Kendall, of Sowerby Bridge, and other members of the Halifax Antiquarian Society, Mrs. P. S. Foster (daughter of the late Colonel F. C. Wemyss), Major E. F. Coates, M.P., Major A. J. Mitchell, Lancashire Fusiliers, Mr. Alfred Hartley, of Halifax, who served as a private in the Regiment, previous to joining the 39th Regiment, in 1859, and many others.

THE HALIFAX MILITIA.

"The independent companies of Militia of this

1760. "town, under the command of Colonel Spencer,
Captain William Ingram and Captain John

"Tarlton, were reviewed by the Earl of Scarborough, in

"Price's Square [now the Manufacturers' Hall] and went

"through their manual exercise, platoon and street-firing.

"The companies were clothed in their new uniforms, "provided at their own expense. The Colonel's Company, "in blue, lapelled and faced with buff; Captain Ingram's "Company, in scarlet coats and scarlet breeches, lapelled "and faced with green, green waistcoats, gold laced hats "and cue wigs, and Captain Tarlton's Company in blue, "with gold vellum button holes.

"Captain Johnson's Company of the train of Artillery, "wore a uniform of blue and buff, with gold laced hats." From the *Halifax Guardian*, October 31st, 1857.

Note.—The writer does not say from where he is quoting, but it appears to be a contemporary account. This is the earliest mention of any Halifax Militia which I have been able to discover.—N. H. M.

About this time, most Regiments appear to have had guns, which were manned by selected men, and at one period each company of a Regiment was required to have a team of trained men. Colonel G. J. Hay, in his "History of the Constitutional Force," states that "In 1802 most regiments had brass six-pounder field pieces."

The old lists in the British Museum also often show "Captains—Artillery" in infantry regiments.

Halifax Churchwardens' accounts:-

1763. September.

"Paid Jos. Hindson, to enlist men for the Militia." [No amount is given, and it is added—"This put to a separate account, and an assessment levied, on purpose for it."]

December.

"To Ben Cropper for a press for the Militia clothes £4 8 8."

November.

1769. "For removing the Militia arms and fixing them at The Talbot £0 6 o."

Payments of £2 10s. for rent for a magazine for the Militia occur in 1767-8-9, 1770-2 and 4.

1778. "For the Militia arms storehouse £0 14 0."

I have been unable to find any further mention of these companies.

In 1783 another corps was raised, which was afterwards nicknamed "The Gallows Guards." The above extracts from the Churchwardens' accounts are taken from the Halifax Guardian of November 7th, 1857, which also states that in 1782 General Hale reviewed the Loyal Irish, and that in 1783 the Earl of Effingham attended the Military Association, at Halifax.

1794. By Act 34, George III.:-

Lords-Lieutenant were authorised to increase the Militia, by raising Volunteer Companies, or men for service with the Militia, during embodiment, on the same conditions as to pay, bounty and clothing, as the Regular Militia.

Three Volunteer corps were raised in Halifax and neighbourhood, at short intervals, under this Act, and one

of them was transferred entirely to the Militia, in 1808, very much in the same way that the Militia transferred to the Special Reserve, one hundred years later.

These corps appear to have trained in a similar manner to the Militia, and trainings of twenty-one days at Wakefield, Doncaster and Pontefract, also permanent duty at the latter place, are mentioned. The non-commissioned officers and men received pay when on duty, though, apparently, the officers did not.

Crabtree, in his "Concise History of the Parish and Vicarage of Halifax," published in 1836, states (p. 149) that in 1795, at the period of the French Revolution "the "turbulent spirit and levelling principle manifested itself to a considerable degree.

"A considerable quantity of muskets, bayonets and other weapons of warfare were sent from Birmingham to Elland, and the disaffected in those parts were trained, in the night, to the use of arms.

"A company of Volunteers was formed in the town, to repress any local disturbance."

The Corps was originally instituted in April, 1794, for the defence of the town, parish and neighbourhood of Halifax.

In February, 1793, France had declared war, and in 1794 Napoleon had driven the English from Toulon.

The threat of French invasion called the people to arms, and in Halifax not only a strong corps of infantry was formed, by a voluntary and almost instantaneous contribution of £7,000, but a volunteer troop of cavalry was raised.

The whole Corps served at that time without pay, but after the fund was exhausted the sergeants and privates received pay from the Government whenever they went on duty, but the officers continued to serve without receiving any remuneration.

On March 16th Lieutenant-Colonel Hudson, commanding the Corps, offered his Majesty their services, in the event of invasion, in any part of Great Britain.

On July 27th the Halifax Corps of Infantry and the Halifax Troop of Cavalry received his Majesty's order, through the Lord-Lieutenant of the County, to hold themselves in a state of the utmost readiness, for such immediate service as the exigency of affairs might require, and also that the Corps should assemble for exercise as frequently as possible, in order to bring it into the best state of discipline.

The strength of the establishment in this year was 352.

The news of the signing of the preliminaries of the Peace of Amiens reached Halifax on Saturday, October 3rd, and great rejoicings took place.

On the following Monday a detachment of the 11th Light Dragoons, stationed at Halifax, and the Halifax Volunteer Cavalry and Infantry assembled, and fired three volleys.

In the evening the town was illuminated.

On October 21st Lieutenant-Colonel Hudson gave a ball in the Assembly Rooms.

The Halifax Journal states:—"The ball concluded and the ladies retired, about three o'clock, the convivial part of the company remaining to a later hour, paying due

honours, in generous libations, to Peace, Plenty and Prosperity."

His Majesty the King, after having very 1802. graciously expressed his approbation of the services of the Corps, was pleased to dispense with their continuance, on the establishment of peace, in April, 1802.

The Corps was disbanded on April 13th, and the colours deposited in Halifax Parish Church.

At the time of being disbanded, only one drummer and fourteen privates were required to complete the establishment.

The peace was of short duration, and on May 1803. 23rd England declared war against France.

A meeting was held in the Piece Hall, on August 13th, and subscriptions were asked for, to raise another corps of Infantry.

The handsome sum of £8,295 13s. 6d. was collected almost immediately.

Other sums followed, and altogether nearly £20,000 was raised.

In order to prevent surprise by the enemy, on November 24th all Chief Constables in the Riding were directed to procure a proper person to take care of the beacons and huts in their divisions.

This would probably be the last time preparations were made on Beacon Hill, Halifax, to signal the approach of an enemy.

As already indicated, a corps of nearly 1,000 men was raised in the town and neighbourhood without taking into account the western portion of the parish, where a second corps was raised.

The Regiment was inspected on Skircoat Moor, on November 19th, by Colonel Gardner, who praised them for their steady demeanour and appearance.

On March 30th Lady Mary Horton, on behalf of the ladies of Halifax, presented colours to the Regiment.

On the following day there was a field day on Skircoat Moor.

On April 1st Colonel Gordon Skelly inspected the Regiment, which subsequently marched to Doncaster, to undergo a course of training for twenty-one days.

The first parade of the Regiment was on April 8th, 1804, when they attended Divine Service, at Sowerby Church, the sermon being preached by the Rev. Joseph Ogden, Chaplain to the Regiment and Vicar of Sowerby.

Colours were presented to the Regiment on April 19th, by Mrs. Moore, of Brockwell.

These colours are now in Sowerby Church.

The Regiment subsequently marched to Wakefield, to undergo a period of training of twenty-one days.

On passing through Dewsbury the men had a most flattering reception, and were most hospitably entertained.

On March 6th, a dinner was given by the 1806. Officers of the Halifax Regiment to their Commander, Colonel Horton, when a cup, value 150 guineas, was presented to him, the presentation being made by Lieutenant-Colonel Ramsden.

In May, 1808, the weavers in the Lancashire manufacturing districts were starving, and rioting took place in Manchester, where troops had to be employed to restore order.

This disposition to riot extended to Rochdale.

On May 31st the Rochdale Magistrates applied for a troop of cavalry from Manchester, and for the Regiment of Halifax Volunteer Infantry.

The latter at once assembled, and at 7 o'clock the same evening marched for Rochdale, sixteen miles off, in a drenching rain.

The day and night following they were accommodated in Rochdale New Church, and the following evening returned home (over 900 strong), having received the warmest thanks of the Magistrates for their steady conduct.

The Commander-in-Chief afterwards expressed the warmest approbation of the conduct of Colonel Horton, Colonel Moore, and the officers, non-commissioned officers and men of the Regiment, for their alert and prompt march to Rochdale.

Act 48, George III., established a "Permanent Local Militia," to replace the regular Militia, when embodied, and in place of Infantry Volunteer Companies, the conditions being:—

"No substitutes, age 18 to 30, service 4 years. Volunteers might transfer to the Local Militia, receiving two guineas bounty. Persons insuring against the payment of ballot fines and penalties, or paying Volunteers beyond two guineas to transfer, to be fined £50.

"No ballot to be taken in any district, if the quota between 18 and 30 years, height 5 feet 2 inches and fit for service, not having more than two children under fourteen years of age, enrol themselves."

The Local, or New Militia, were to train annually, in the spring.

"The force was continued until the end of the war, —
"June, 1815, and abolished by Act 55, George III., which
"received the Royal Assent, four days after the battle of
"Waterloo.

"It is stated that, by the above transfer of Volunteers and the ballot, over 210,000 men were raised for the Local "Militia."

Halifax Volunteer Infantry transferred to the Militia.

The Regiment was assembled on Skircoat Moor, on May 5th, 1808, when Colonel Horton explained the Government plan for transferring the Volunteers to the Local Militia.

The invitation to join the Militia was received with a burst of loyalty and applause.

On July 7th, when assembled in the Piece Hall, the whole of the officers and non-commissioned officers and 827 privates offered their services as Local Militia.

The Regiment was 1,000 strong, so that it was practically unanimous.

The colours, which were worked and presented to the Regiment, by Lady Mary Horton, in 1804, are now in the possession of Mr. T. J. Horton, at Howroyde.

Colours, the cost of which had been subscribed by the inhabitants of the town, were presented to the Regiment on June 9th, 1809, at Pontefract, where it was then stationed, on permanent duty.

Note.—The Commissions of Lieutenant-Colonel Thomas Horton and Lieutenant Robert Parker are now in Bankfield Museum, Halifax.—N. H. M.

In the Militia Lists, in the British Museum, in 1811. the 1811 Volume, page 264, which is the last mention of the Halifax Local Militia I have been able to find, Lieutenant James Cartledge was promoted Captain, on March 18th, 1811.

Lieutenants Samuel Smith and John Ingham had left the Regiment, and the following Ensigns were promoted Lieutenants, on March 18th, 1811:—B. K. Rogers, J. W. Gregory, Blakey Spencer and Thomas Boothroyd.

Thomas Firth and Joshua Normanton were gazetted Ensigns, on February 9th, 1811.

The following articles are now in the Bankfield Museum,

Coat, waistcoat and knee-breeches of an officer of the First Halifax Volunteer Regiment. Date, about 1803. The coat is scarlet, with green facings, the waistcoat and knee-breeches being white cloth.

A silver badge, worn by the Halifax Volunteers, about 1808. Motto—"Ready to serve our country."

A sword, with the inscription, "Halifax Local Militia," on the belt-plate.

A pair of epaulettes, with Crown, H.V., and a grenade.

A brass gorget, lined with wash-leather.

Note.—The gorget was the last relic of armour retained by the infantryman, when the rest was discarded. Originally it was the collar-piece, for guarding the throat, and was of some size.

Growing gradually smaller, it finally became a mere ornament, attached to the collar of officers.

It usually bore either the regimental device, or the Royal Monogram, and ceased to be worn about 1838. The French Army continued to wear it up to 1881.—(British Military Prints)—N. H. M.

Also, in the Officers' Mess, at the Barracks, a metal drum, painted green and yellow, standing on claw feet.

Painted on it G.R., the York Rose, 1st H.L.M., and the Prince of Wales' Feathers.

Note.—Colonel Cecil Conor, who was a subaltern at the Depôt at the time, informs me that the drum was found in a local pawnshop, about 1879.—N. H. M.

From 1815 until 1852 the whole Militia Force was practically in abeyance. The staffs were reduced, and under Act 5, William IV., "the arms and appurtenances were withdrawn."

In 1835 another order further depleted the staffs. Few regiments have continuous records for the years 1815-1852, though in some cases the adjutants and permanent staffs remained unchanged.

In November, 1848, a War Office circular directed attention to the contingent allowance of regiments, which had been allowed to accumulate during the years in which regiments were not called up for annual training.

Colonel Hay, in the "Constitutional Force," quotes one instance, in which £1,181 16s. 8d. was thus accumulated.

The Militia is the oldest form of military service in the country, and regarding it, history constantly repeats itself.

In times of peace it has been neglected; at the first rumours of war it has once more received attention and encouragement.

The Force was increased, and regiments were embodied during the "Seven Years" War, 1758-1763; the American War, 1778-1783; in Ireland, 1798; the French wars from 1803-1815; the Crimean War, 1854-1856; Indian Mutiny, 1857-1860; and the South African War, 1900-1902. From the disbandment of the Halifax Militia, in 1815, until 1853 the town was not called upon to raise any Militia.

In 1852 it was determined by Act of Parliament "to "render available the Militia Forces, and at the same time "to increase the number of regiments, in proportion to "the increase of population."



1853. York Militia having been decided upon by an Act
July 15. of Parliament, 15 and 16 Vict., Cap. 90, and
Militia Regulations appended thereto, dated War
Office, 15 July, 1853, which was presented to Parliament
pursuant to Act 15 and 16 Vict., Cap. 90, Section 14, and
page 69, its Headquarters were temporarily established at
Leeds, till the Lieutenancy meeting of October, 1853, when
it was removed to Halifax, as its permanent Headquarters.

Enrolment.—The enrolment commenced with No. 1 Paymaster-Sergeant John Chadwick, on January 8th, 1854, and the last man enrolled to the end of the first training, on Dec. 30th, 1855, was No. 1107 Pte. James Horsfall.

The Battalion carried out its first annual

1855. training of twenty-eight days, at Halifax in

December, and was inspected by Colonel Haget,

7th Hussars.

The parade state for the inspection, on December 29th, shows there were present 15 officers, 23 N.C.O's. (permanent staff), 10 drummers, and 253 privates. Nine officers were absent with leave, and one officer and 526 privates without leave.

The men were accommodated in billets, and the officers messed at the Old Cock Hotel, the Battalion store and place of assembly being in Fountain Street, in a building which had previously been a malt-kiln.

The Headquarters and stores were afterwards moved to a building in Victoria Road, Hanson Lane, which had previously been the old Debtors' Jail, whence they were moved to the present barracks in 1877.

The Regimental Hospital was in the yard at the back of the Northgate Hotel. The companies each had their own Headquarters, at which they were paid daily.

The Northgate Hotel was the Headquarters of No. 4 Company.

No Militia N.C.O's., or, as they were styled at this time, "Volunteer" sergeants and corporals had been appointed.

To complete establishment 2 Lieutenants, 7 Ensigns, 1 Assistant Surgeon, 1 Quartermaster and 303 privates were required.

Officers.—Officers were evidently more easily obtained in those days than at the present time, as 30 had been gazetted up to the end of the first training.

Colonel Hind was a colonel on the half-pay unattached list, and had served in the 45th Foot, his first commission in the Army being dated October 8th, 1829. He commanded up to 1872. He was promoted Major-General (half-pay) on March 6th, 1868, and Lieutenant-General on October 1st, 1877.

Major Robert Stansfeld served for 11 years in the 19th Foot, with which Regiment he served in the West Indies, retiring August 4th, 1837. In 1852 he was captain in the 2nd West York Militia.*

Captain Godfrey Armytage, the first adjutant, had served as a captain in the 6th Foot.

Major F. J. Bayly served for 23½ years in the 91st Foot, retiring in March, 1854. He served in the Kaffir War, 1846—1847, and Insurrection of Boers, 1844—1845.

Captain H. de C. Lawson had served in the 3rd Dragoon Guards.

Captain C. H. Rhys in the 26th Foot.

Captain William Coates was previously a captain in the 98th Foot.

Captain J. S. Scott retired as a captain from the 31st Foot.

Lieutenant H. J. Noyes had been a lieutenant in the 26th Foot. He transferred to the Royal Glamorgan Militia in 1856, and died in February, 1860.

Lieutenant D. B. Moriarty was transferred to the 6th Foot, in December, 1859, and later to the 80th Regiment.

Ensign John Stansfeld joined the 1st (Royal Scots) Regiment in April, 1856, and later served in the 2nd Dragoons (Scots Greys), retiring as a captain.

Officer Joining.—The Regiment did not train

1856. this year, and the only fact recorded in the records is that Charles Musgrave Norris was gazetted lieutenant on September 27th.

Recruiting.—Recruiting appears to have been very good, and over 400 men joined the Regiment.

Training.—The Regiment trained at Halifax in 1857. October, for 28 days, and was inspected on the 26th by Colonel Douglas, Inspector-General of Militia. The parade state shows that 14 officers and only 40 privates were required to complete establishment, whilst the absentees, without leave, had dropped from 526, in 1855, to 235. On September 17th George Goodwin Norris was gazetted ensign.

Up to the present the Regiment had been without a quartermaster, but on December 3rd William Coates was appointed. He was promoted Captain, December 29th, 1859. He had previously served as a captain in the 98th Foot, and as a captain in the Regiment since October 24th, 1854. In 1860 he became the first adjutant of the 1st West York Rifle Volunteers.

Training.—The Regiment trained at Halifax for 21 days, and was inspected on October 18th by Colonel Hardinge, 22nd Foot.

Eight "Volunteer" sergeants and 22 corporals had been appointed since the previous training.

Three hundred and sixty-five men were present at training, and there were 155 absentees. Five hundred and twenty-five men were required to complete establishment, against only 40 in 1857, and I can find no explanation in the records, but from this year onwards the Regiment always required several hundred men to complete establishment.

Officers Joining.—The following officers joined the Regiment:—

Ensign E. C. Bond, May 14.

Assistant-Surgeon H. J. Hunter, June 24.

Captain R. McF. Hammond, July 1.

Ensign Bond was promoted lieutenant August 23, 1861, and captain July 27, 1870.

Captain Hammond had been a captain, 20th Bombay Fusiliers.

Training.—The training took place at Halifax, in July, 19 officers and 689 men being present.

The Regiment was inspected on July 22nd by Colonel Shaw, 45th Foot.

This training was remarkable for the excessive heat. The hospital was full, and many men were laid up in their billets with blistered faces, and eyes nearly closed by the sun.

The Regiment at this time was very proud of its Bugle and Drum and Fife Band, which was in charge of Drum-Major Carter, late Coldstream Guards, and it was probably owing to his influence that about this time the Regiment sent a large number of men to the Brigade of Guards.

Officers Joining.—The following officers were appointed:—

Lieutenant R. E. W. Garnham, March 7.

Ensign John Birkbeck, April 3.

Captain H. F. Davis, July 13.

Lieutenant Garnham served 22 years in the Regiment. Captain, January 28th, 1861; Major, May 11th, 1874; Lieutenant-Colonel, June 11th, 1879; retiring May 6th, 1882.

Ensign Birkbeck served in the Regiment until 1869.

Note.—Mr. Alfred Hartley, now living in Halifax, was a private in No. 4 Company at this time. In 1860 he joined the 39th Regiment, four years later transferring to the 85th Regiment.

After 14 years' service he retired on pension as a Colour-Sergeant.

Mr. Hartley remembers seeing the first recruits of the Volunteers in Halifax being drilled, their first Instructor being a corporal of the Kerry Militia, then embodied in York.

Distinctive Badge granted.—The Regiment, up to this time, had apparently been without a badge, the uniform being scarlet, with sky-blue facings.

The following is a copy of the original document granting the badge:—

Training.—The training took place at Halifax in June, 19 officers, 525 N.C.O.'s and men being present.

The Regiment was inspected on June 28th by Colonel Willis, 84th Foot.

Order for Training.—This is the first year in which I have been able to find the actual order for the training of the Regiment, which is as follows:—

MY LORD,

Referring to my circular of the 5th September, 1860, enclosing a copy of the Act of last Session, Cap. 94, amending the laws relating to the Militia, the 14th section of which provides that Volunteers may, upon, or at any time hereafter enrolment, be drilled, trained, or exercised, by way of preliminary instruction, for any time, not exceeding 28 days, in addition to the ordinary annual training, I have now the honor, in pursuance of such Laws,

to signify to you Her Majesty's pleasure that those volunteers of the corps named in the margin, who may not have been already trained, 2nd, 4th, 5th, & 6th W. York,* be called up for preliminary instruction in the year 1861, for a period of 14 days, immediately preceding the date of the annual training and exercise, which latter is not to exceed 24 days.

I have further, with reference to your answer to my circular of March 12th, to inform you that Her Majesty has been graciously pleased to appoint the 24th April next as the date on which the said corps shall assemble at their Headquarters for Twenty-four days' Training and exercise.

The Regiment trained at Halifax, and was inspected on May 13th by Colonel Campbell, the strength being 15 officers and 559 N.C.O.'s and men.

Lieutenant George Stansfeld was promoted Captain December 19th, 1863; Major, June 11th, 1879; Lieutenant-Colonel (commanding 4th Bn. 1884-1887). August 25th, 1904.

Order for Training.—The Order for Training 1862. of this year, dated War Office, March 5th, fixes May 8th as the date of assembly, for twenty-one days' training, at Headquarters, and also directs that all men

who had not made sufficient progress to join the ranks the previous year, should be called up, with the recruits, for 14 days' preliminary training.

This order is evidently the fore-runner of that by which recruits, in the later days of the Militia, who had not completed their 40 days' recruits' drill, at the Depôt, by the commencement of the Battalion training, did not go out with the recruits' musketry party or the Battalion, but completed 76 days at the Depôt, and did not fire their recruits' course of musketry, until their second year of service.

Training.—The strength of the Regiment at inspection, at Halifax, on May 23rd, was 16 officers and 618 N.C.O.'s and men. The inspecting officer was Colonel Goodwyn, 41st Foot.

Officers Joining.—The following officers joined the Regiment:-

Lieut. S. Wing, March 14th.

Lieut. G. Perkins, March 25th.

Capt. R. Croker, October 10th.

Captain Croker had served in 3rd Dragoon Guards (Lieut. Nov. 22nd, 1844). He was promoted Major July 22nd, 1874, and resigned his commission March oth, 1875.

On December 2nd, Robert Malcolm who had previously been quartermaster of 25th Foot (27th April, 1849) was appointed Quartermaster to the Regiment, in which he served until his death in October, 1873.

Officers Joining.—The following officers were 1863. appointed:—

Lieut. P. Serle, February 28th. Asst.-Surgeon J. H. Wright, March 23rd. Capt. F. C. Wemyss, July 30th.

Captain F. C. Wemyss was promoted Major, March 10th, 1875; Lieut.-Colonel, May 13th, 1882; Commandant 3rd and 4th Battalions, 1884—1894; Hon. Colonel 3rd Battalion 1900 until his death on Christmas Day, 1905.

He had previously served as an Ensign in the Royal Wiltshire Militia, his commission being dated October 31st, 1857, and was embodied with this Regiment from October 1857—April 1860.

For further particulars see pages 84-85.

The order for Training is dated Leeds, February 23rd, 1863, and issued by order of Earl FitzWilliam, who had succeeded the Earl of Harewood as Lord Lieutenant of the West Riding.

The Regiment assembled at Halifax on April 28th, for 21 days' training, the recruits being called up 14 days previously.

Training.—20 officers and 695 N.C.O's. and men were present on parade on May 16th, when the Regiment was inspected by Lieut.-General Sir George Wetherall, K.C.B.

Training.—The Regiment assembled for Training at Halifax on April 18th.

Officer Joining.—Captain M. P. Macqueen, late 91st Foot, was appointed Captain on April 1st, vice Captain J. B. Swann, retired.

Up to this time the Regiment had been without Colours, and on April 29th the first Colours were presented by Mrs. (afterwards Lady) Edwards, of Pye Nest.

Presentation of Colours.

Presentation of Colours, April 29th.—The following account is taken from the Halifax Guardian of April 30th, 1864:—

"Unusual bustle and excitement were created in the town yesterday afternoon, by the ceremonial of the Presentation of Colours to the 6th West York Regiment of Militia, now embodied for the annual period of 21 days' training.

"The weather proved all that could be desired in the way of clear sky and bright sun, the only drawback being the dense and blinding clouds of dust, raised on the roads, owing to the long continued dry weather.


"With laudable foresight the Corporation caused all the roads leading towards the moor to be well watered before the hour named for the ceremony.


"Soon after two o'clock, large crowds began to wend their way to Skircoat Moor, the scene of many festive gatherings connected with Halifax, and destined that day to be the site of a display that will rank first amongst the kind occurring in Halifax for many years back.

"The Regiment mustered in St. John's Lane at 3 o'clock, and shortly after that hour set out to march for the moor.

"Previous to this, a party of six sergeants attended at the Orderly-room, in Fountain Street, to receive the Colours, which were draped, and escorted them to the parade ground, placing them on the reverse flank, facing the column.

"Not many minutes before the Regiment arrived on the moor the large crowd was scattered all over the parade ground, but by the efforts of a body of the West Riding Police, a large square was speedily formed, on all sides the utmost good humour prevailing.

"At a quarter past three o'clock the head of the column was seen mounting the crest of the hill above Bell Hall, and soon the long line of red coats streamed across the moor, until it stretched almost from one end of the principal "flat" to the other. Perhaps there has never been so large a muster of any single regiment in Halifax before, certainly not for many years back. We understand that every man at present on duty was in attendance, and out of the enrolled strength of the Regiment there were only 29 absentees.

"The total muster was 676 of all ranks, and the clean, tidy and soldierlike aspect of the men was commented on by everyone: The officers present were:—Colonel C. Hind (Commandant), Major R. Stansfeld, Captains H. de C. Lawson, C. T. Hyde, E. F. Boultbee, F. B. Cooper, R. E. W. Garnham, R. Croker, M. P. Macqueen, G. Stansfeld, and F. C. Wemyss, Lieutenants E. C. Bond, J. Birkbeck, A. B. Foster, and P. Serle, Captain and Adjutant G. Armytage, Surgeon Lawrence Bramley, Asst.-Surgeon J. H. Wright, and Quartermaster R. Malcolm.

"Breaking into open column of ten companies, the Regiment remained until about a quarter to four o'clock, when it was wheeled into line, the Colours and Sergeants' Guard being in rear of the centre.

"Shortly before 4 o'clock, an escort of 30 men of the 2nd West Yorkshire Yeomanry Cavalry, under the command of Captain J. P. Edwards, arrived on the ground. A short time afterwards, the carriage containing Mrs. Edwards, Miss Edwards, and Miss G. Edwards drove on the ground, punctual to the time appointed for the presentation—4 o'clock. The regiment was then formed into three sides of a square, two deep, No. 1 Company being marched off and wheeled into the vacant space, facing inwards.

"The Yeomanry occupied the rest of the line, facing the square. The Colours were placed on the drums, the heads being towards the centre company.

"In front of this stood the Venble. Archdeacon Musgrave, D.D., robed in his black gown, scarlet hood and college cap.

"Facing him, by the head of one Colour, was Mrs. Edwards, near to whom was Colonel Edwards, and by the other Colour was Colonel Hind, Commandant of the Regiment.

"Grouped around were about fifty ladies and gentlemen, including some of the leading families in the town.

"The Archdeacon having given a short address, followed by prayers, appropriate to the occasion and the Consecration of the Colours, handed the Colours to Mrs. Edwards.

"Lieut. J. Birkbeck and Lieut. A. B. Foster then advanced, and kneeling, received the Colours—Lieut. Birkbeck taking the Queen's and Lieut. Foster the Regimental Colour.

"Mrs. Edwards then thanked Colonel Hind, officers, N.C.O's. and men for the honour of presenting the Colours, and hoped the day was far distant when they would be seen on any but peaceful occasions, but was confident that if ever necessity arose the Regiment would bear them triumphantly to victory.

"The two lieutenants then marched to the front of the guard of honour—No. I Company, under command of Captain H. de C. Lawson, who received them with presented arms, the Regimental band playing the National Anthem. Colonel Hind then addressed the Regiment:—

"Soldiers, these are your Colours. I call on you to respect them. Stand by them. They are to animate and encourage soldiers when they go into battle. They are

likewise emblematic of many virtues—fortitude, obedience, discipline. Without discipline an army will never be good. Discipline is the perfecting of a regiment. It is a part of the whole. Order strengthens men. Disorder weakens a man's courage. I beg you to observe the few words I have spoken, because they are words of truth.'

"Colonel Hind then, in the name of the Regiment, thanked Mrs. Edwards for presenting the Colours, and for the hospitality and kindness which the Regiment had always received from her family.

"He also thanked the Archdeacon for performing the ceremony of the Consecration of the Colours. The Colours were then 'Trouped.' At the conclusion of this ceremony the Regiment presented arms and gave three cheers for the Queen and for the Colours.

"The Regiment then marched past in column, in 'slow' time, returning in quarter column in quick time.

"This closed the proceedings, the men leaving the moor at a quarter past 5 o'clock, and the crowd, estimated at between 4,000 and 5,000 in number, rapidly dispersed.

Marching down King Cross Lane, Silver Street, and Crown Street, the long line of soldiers passed along Northgate and up Crossley Street, stretching from the bottom of that street to the top end of John Street. Here they were dispersed, the Colours being deposited at Headquarters, at the White Swan Hotel."

DESCRIPTION OF THE COLOURS.

The Colours were of the new pattern, and were approved by the Herald's Office. They were smaller than the old pattern, the spearhead being replaced by a crown, surmounted by a Lion rampant, in Silver Gilt. The Queen's Colour, presented by the Government, had the St. George's Battle Cross, upon the Union Jack. In the centre was a large crown, with an amber label underneath, bearing the motto, "6th West York Militia." It was edged with bullion fringe, and had gold cords and tassels. The Regimental Colour, presented by Colonel Hind, had a field of sky-blue (the facings of the Regiment). At one corner the Union Jack, and in the centre a crimson circle, charged with the White Rose of York. Encircling this, a wreath of the Rose, Shamrock and Thistle, and a label, with the name of the Regiment, in gold. It had also gold cords and tassels, and was edged with bullion fringe.

These Colours are now (1910) at Sandringham. On the presentation of new Colours to the Battalion by H.R.H. the late Duke of Clarence, on Halifax Racecourse on July 30th, 1889, the Duke of Clarence expressed a wish to have the old Colours, which were presented to him and placed in Marlborough House.

I have been informed by General the Right Honourable Sir Dighton Probyn, V.C., that they remained there until 1900, when they were removed to Sandringham. On applying for permission to have the Colours photographed, Sir Dighton Probyn informed me that by special permission of His Majesty the King, the Colours would be photographed at Sandringham, and copies sent to me.—N. H. M.

Six days' pay was voted for the expenses of the regimental dance, which took place on May 24th, and two days' pay for the Band Fund.

For the first time since its formation, the 1872. Regiment trained away from Headquarters.

Orders were received from the Assistant Adjutant-General's Office at York, that the recruits undergoing their preliminary drill were to train with the Regiment, which assembled on May 13th, and went into camp at Pontefract. This was the first time the Regiment had trained under canvas, as previously the officers lived at the White Swan Hotel and the men had been billeted in the town.

Only 429 non-commissioned officers and men appear to have been present, and 220 men were absent, without leave, whilst 209 trained recruits were excused training. Removal of Headquarters to the New Barracks.—The new barracks were erected in Halifax in 1877, and the 9th Brigade Depôt formed there on September 1st. On October 1st the arms, clothing, necessaries, and other stores were removed from the buildings, provided by the county in Hanson Lane, and stored in the Armoury at the new Barracks, the Headquarters of the Permanent Staff being moved at the same time. On the formation of the Brigade depôt, it was recommended by the officer commanding the Regiment that, as an experimental measure, the recruits enrolled during the non-training period should be quartered in the barracks and drilled on enrolment, and between October 15th, 1877, and June 6th, 1878, 555 recruits were enrolled and drilled, dismissed to their homes, and not required to attend the training of 1878.

Mobilization of the Militia Reserve.—During

1878. April the Reserves were called out for Mobilization, in consequence of a threatened war with Russia, and of 203 men on the strength of the Regiment, who had enlisted for service in the Reserves, 187 reported themselves and were, with the exception of a few, who were found medically unfit, sent to join the linked home battalion—76th Regiment—to which they were attached, until demobilization on July 31st (Colonel Hayden's History of 76th Regiment).

In consequence of the recruits not being required to attend training, and the absence of the Reserve men with the Regular army, the numbers attending the training of 1878 were comparatively small.

On April 26th H.R.H. the Commander-in-Chief, by the Queen's command, issued a General Order expressing Her

Majesty's high opinion of the very satisfactory manner in which the men of the Army Militia Reserve had responded to the call made on them to join the Army for permanent service.

3RD AND 4TH BATTALIONS DUKE OF WELLINGTON'S (WEST RIDING) REGIMENT.

Introduction of the Cardwell System.—The

1881. following General Order, dated April 11th, was
promulgated for the organization of the Infantry
of the Line and the Militia:—

Organization.—The Infantry of the Line and the Militia will in future be organized in Territorial Regiments, each of four Battalions, for England, Scotland, and Wales, and five Battalions for Ireland, the 1st and 2nd of these being Line Battalions and the remainder Militia. The regiments will bear a Territorial designation corresponding to the localities with which they are connected.

By a subsequent order the 33rd and 76th Regiments became the 1st and 2nd Battalions the Duke of Wellington's (West Riding) Regiment, and the 1st and 2nd Battalions 6th West York Militia, became the 3rd and 4th Battalions of the same regiment.

The officers' silver lace and silver buttons and ornaments were given up for gold lace and gilt buttons, and the old sky-blue gave place to the white facings of the Line battalions.

The only distinctive badge was the "M," which officers were on their shoulder-straps, until the conversion of the Militia into Special Reserve, when the uniform became, in every respect, similar to that of the Line.

For some years the men also wore an M above the Regimental title, but this was unpopular, and a conference of Militia Commanding Officers was held at the War Office, to decide what distinctive badge should be worn.

It was decided that the men should wear a numeral, but that the officers, who were proud of their old county Militia Regiments, should continue to wear the "M."

Note.—The old helmet-plate was similar to the present pattern, but plated. In the centre was the York Rose, surrounded by scroll, with title, "Sixth West York."

The waist-clasp of the sword-belt was of similar design to the centre of the helmet-plate, and was also plated.

The buttons were white metal and bore the regimental badge—the York Rose, surmounted by Crown, and the title of the Regiment.—N.H.M.

PRESENTATION OF COLOURS.

Presentation of Colours by H.R.H. Prince Albert Victor, K.G.—H.R.H. Prince Albert Victor, Duke of Clarence, Major, 10th (Prince of Wales's Own Royal) Hussars, then stationed at York with his regiment, presented new Colours to the 3rd and 4th Battalions Duke of Wellington's West Riding Regiment, on the Racecourse, on July 30th. The 4th Battalion had, previously, been without Colours.

The Colours were uncased by Major G. Stovell and Major A. K. Wyllie, the senior Majors of the battalions, and the ceremony of consecration was then carried out by the Regimental Chaplain, the Rev. Canon J. H. Warneford.

Major Stovell then took charge of the Queen's Colour, and handed it to the Prince, from whom it was received by Lieutenant Johnston, senior subaltern of the 3rd Battalion.

In like manner the Regimental Colour was taken by Major Wyllie and received by Lieutenant W. M. Brown, 4th Battalion.

The other pair of Colours were similarly received by Lieutenant H. S. George, 3rd Battalion, and Lieutenant St. J. G. S. Clerke, 4th Battalion.

Colonel Wemyss then thanked His Royal Highness for the great honour he had done them, and gave a brief sketch of the history of the two battalions.

H.R.H. Prince Albert Victor, after addressing the battalions, presented medals for Long Service and Good Conduct to Quartermaster-Sergeant Meaton and Sergeant Dicker.

The battalions, having re-formed line, gave a Royal Salute, after which they marched past, together with the 1st Volunteer Battalion and the 2nd West Riding of Yorkshire R.G.A. (Volunteers).

The latter corps fired a Royal Salute on the arrival and departure of His Royal Highness.

Between 30 and 40 veterans were also on parade, including Sergeant-Major Akroyd, the first Sergeant-Major of the 6th

West York Militia, who was present on parade when the Colours, just given up, were presented by Lady Edwards, in 1864.

From "The Court Circular," September 7th 1889.—Colonel F. C. Wemyss was received at Marlborough House, attended by Captain G. Morley Saunders, Adjutant and Lieutenant H. J. Johnston, together with Colour-Sergeants Allen and Robertson, escorting the old Colours of the 6th West York Militia, which His Royal Highness Prince Albert Victor was graciously pleased to accept, having presented the 3rd and 4th Battalions Duke of Wellington's (West Riding) Regiment with new Colours, at Halifax, on July 30th last.

Inspection by Field-Marshal the Duke of Cambridge, K.G. (Commander-in-Chief).—During the training, Field-Marshal H.R.H. the Duke of Cambridge, K.G., reviewed the troops in camp at Strensall, together with the 3rd West Riding Regiment from York Barracks, and the 6th Dragoon Guards.

His Royal Highness was accompanied by a large staff, including General Sir Redvers Buller, Adjutant-General of the Forces, Major-General Sir F. W. Grenfell, General Sir R. Biddulph, Quartermaster-General of the Forces, Sir H. Havelock-Allan and Major-General Wilkinson, C.B., commanding the North-Eastern District.

After the usual ceremonial parade the troops were formed up and addressed by His Royal Highness, who said that he had come a good distance to have the opportunity of seeing what the Militia of the North could do under any circumstances, and he was very glad that he had come, because the result to his mind was highly creditable to all the corps and to the Northern forces of England.

The Militia had turned out under favourable circumstances—if they liked—fine weather, very good camp; and still under difficulties, because camp life was always more difficult than barrack life.

Notwithstanding this, the Regiments had turned out very clean, very smart and very efficient, a proof that those who had to do with them and manage them were not only well acquainted with their duties, but, also, that they had done their best to produce the result which he had seen on parade that day.

He could only tell the Militia that nothing could be more satisfactory, in his opinion, than their present condition, and he had the more pleasure in telling them that because he had sometimes seen it doubted that the Militia was appreciated as it deserved.

No man appreciated it more than he did, and there was no man more ready to give them that assistance which it was in his power to give.

If any of them had ever had the impression that that was not the case, he could only assure them that they had been very much misinformed. The difficulties they had to deal with were not military, but purely and simply financial. There were things which might be done and which he should like to see done, but he was always met with the difficulties of finance. That was not his business, unfortunately. He was not responsible for that, but he was responsible for the efficiency of the service, and anything he could do to assist the Militia, or any other branch of the service, in order to make them more efficient, they might depend upon it, he would always try to do.

On July 29th the Battalion was inspected by Major-General Wilkinson, C.B., commanding the North-Eastern District, who, in the course of his remarks, when addressing the Battalion, said the men reflected honour on the service to which they belonged, and only the previous week had received from the Duke of Cambridge the highest honour that any branch of the service could receive. The civil authorities had also reported to him that their conduct in the City of York had been most exemplary.

It was an honour for Colonel Wemyss to command such a battalion.

On August 3rd Colonel Fenn, commanding the 33rd Regimental District, made the annual inspection of the Battalion, and thoroughly endorsed the very flattering remarks of H.R.H. the Duke of Cambridge and Major-General Wilkinson.

Training.—Application was made for the 1894. Battalion to train at York, but the barracks were not available, and it was pointed out that as the Battalion had not trained at its headquarters for four years, it was advisable that it should do so, if possible, this year.

There was, however, a difficulty about the Copley Range, and the Battalion assembled on July 2nd and trained at

Strensall, when it formed part of the 15th Brigade 3rd Army Corps.

On July 24th the Militia Brigade and the troops from York were inspected by Major-General Wilkinson, C.B., commanding the North-Eastern District. There were also present Her Majesty's Judges of Assize—Justices Cave and Grantham, and the United States Ambassador, Mr. Thomas Bayard.

The following day Colonel Harrington, Camp Commandant, presented the Royal Humane Society's Certificate for life-saving to Private Clagge, of the Battalion.

On July 27th, at Mess (this being the last training under Colonel Wemyss) some most touching speeches were made, and the greatest regret expressed by everyone present at the Colonel's compulsory retirement, owing to age.

Colonel Wemyss presented the officers with a silver statuette, representing a private of the regiment, in full marching order, which was most gratefully accepted to serve as a lasting remembrance of the many happy years they had had the honour of serving under him.

Retirement of Colonel Wemyss.—On November 13th Colonel Wemyss retired from the command, after 39 years' service in the Militia.

He was the son of the late Lieutenant-General Wemyss, C.B., Colonel of the 17th (Leicestershire) Regiment, who

served throughout the whole of the Peninsular Campaign, and commanded at Manchester during the Chartist Riots.

He was born at Pontefract on May 9th, 1834. He entered the Royal Wiltshire Militia, as ensign, October 31st, 1857, lieutenant June 6th, 1858, was embodied two years and seven months at Aldershot, Portsmouth, Dover, Walmer, and other places.

In 1860 he was appointed to Her Majesty's Hon. Corps of Gentlemen-at-Arms.

In 1862 he transferred to the 6th West York Militia, commanded by the late Major-General Charles Hind, became Captain July 30th, 1863, Major March 10th, 1875, Hon. Lieutenant-Colonel 1882, commanding the 4th Battalion, and succeeded Colonel F. J. Bayly as Commandant 3rd and 4th Battalions April 16th, 1884. In 1889 his command was specially extended for five years.

During his command the Battalion sent over 1,200 men to the Regular Army.

On his retirement, Colonel Wemyss was presented by Sergeant-Major W. Jolley and the Permanent Staff with a photographic group of themselves as a small mark of their respect and esteem.

Colonel Wemyss succeeded the Duke of Wellington as Hon. Colonel of the Battalion, on October 3rd, 1900.

Taken from the Battalion "Digest of Services," chiefly compiled by Major and Adjutant F. A. Hayden, D.S.O.

Major Hayden kept a complete diary of the movements of the Battalion until he took over temporary command early in January, 1902.

SERVICE DURING EMBODIMENT

From January 17th, 1900-May 28th, 1902.

Embodiment.—In consequence of the reverses

1900. of Stormberg, Colenso and Magersfontein, which
occurred during the first week of December, 1899,
large reinforcements of Regular troops were despatched to
South Africa. To replace men at home, additional Militia
Battalions were embodied, a few having been already
embodied, late in November and early in December.

Notice was received about January 1st, 1900, that the Battalion would be embodied on the 17th, and would proceed to Cork, but only 340 non-commissioned officers and men were to be called up, in the first instance.

These assembled at Halifax on the 17th, and proceeded the same night from Pellon Station to Cork, via Manchester, Holyhead and Dublin, arriving at Cork about 9 a.m. on the following day.

Captain G. C. Goldie, late 3rd Yorkshire Light Infantry, joined on February 17th, transferred from the Reserve of Officers.

Volunteering for Service Abroad.—On January 31st the Battalion volunteered for service abroad.

Warned for Service.—On February 15th the Battalion received orders to hold itself in readiness to embark for

South Africa on February 25th, but this date was subsequently altered to the 27th.

Extension of Adjutancy.—Under War Office authority, the period of the Adjutancy of Major F. A. Hayden (which expired in February) was extended to August 12th, 1901.

Promotion.—Captain and Hon. Major E. L. Cordes was promoted Major on February 23rd, vice Heydemann, retired.

Embarkation for South Africa. — The Battalion embarked for South Africa at Queenstown, on February 27th, on the ss. "Goorkha" of the Union Line.

2nd-Lieutenant A. C. Adams joined on February 27th, immediately after the Battalion had embarked, on first appointment.

The 4th Bedfordshire Regiment embarked on the ss. "Goorkha" on the same date.

Strength.—The strength of the Battalion on embarkation was 27 officers, and 488 N.C.O.'s and men.

Death.—No. 5500, Private T. McDermott, "E" Company, died at sea, on March 12th.

Arrival at Cape Town.—The Battalion arrived in Table Bay about 2 p.m. on March 20th, and disembarked on the 23rd, proceeding the same night by troop train to Worcester (109 miles from Cape Town).

Resignation.—Captain Bulteel did not accompany the Battalion to Worcester, and subsequently resigned his commission.

Moves.—"C" Company, under command of Captain and Hon. Major Bruce, proceeded to Wellington (38 miles) on March 27th.

"A" Company proceeded to Wellington on April 14th to reinforce "C" Company.

Death.—No. 366, Private J. Hart, "A" Company, died at Wellington, on April 20th.

Maxim Detachment.—Lieutenant C. E. B. Hanson joined from England, with the Maxim detachment and Maxim gun, on April 24th.

Moves: Detachments.—"E" Company, under 2nd-Lieutenant Greenwood, to Laingsburg (213 miles). "G" and "H" Companies, under Captain Goldie, to Tunnel Siding. "I" Company, under Captain Mayor, to Touws River. "K" Company, under Captain Digby, to De Doornes (26 miles). The above moves took place on May 2nd.

Transfers to Regular Army.—2nd-Lieutenant Liddell was gazetted to the West Riding Regiment on April 4th, and left Worcester on May 3rd to join 1st Battalion.

2nd-Lieutenants Herapath and Greenwood were gazetted to the West Riding Regiment on April 18th and 21st respectively, and were posted to the 2nd Battalion.

2nd-Lieutenant Wills was gazetted to the 18th Hussars on April 21st.

Draft.—A draft of 46 men arrived from the depôt and joined at Worcester on May 24th.

Detachment.—The detachment at Wellington, under the command of Captain Wayman, was moved to Tulbagh Road (75½ miles) on May 23rd.

Death.—Lieutenant-Colonel the Duke of Wellington, K.G., Honorary Colonel of the Battalion, died in England, on June 12th.

Move.—The Companies on detachment (except the detachment at Tulbagh Road) proceeded to Simon's Town, on July 2nd, relieving the 4th West Yorkshire Regiment there.

Headquarters moved to Simon's Town on July 4th, taking up the detachment at Tulbagh Road en route.

The 4th West Yorkshire Regiment relieved the Battalion at Worcester and also the detachments at Touws River, Tunnel Siding, De Doornes and Tulbagh Road. The detachment at Laingsburg was relieved by the 3rd Royal West Surrey Regiment.

Duties: Guarding Prisoners of War.—On arrival at Simon's Town, the Battalion took over charge of 1,500 prisoners of war, and remained in charge of them, until departure, the number of prisoners of war varying during the whole period from 1,300 to 2,000.

Move: Detachment.—On July 5th, "F" Company, under 2nd-Lieutenant Greenwood, proceeded by march route to Wynberg, to relieve the Company of the 4th West Yorkshire Regiment.

Draft.—On July 12th a draft arrived from the depôt, consisting of 2nd-Lieutenant W. B. Goddard and 116 N.C.O.'s and men, all of whom, with the exception of one sergeant (Permanent Staff), were recruits for the 1st Battalion.

Extract from Battalion Orders, No. 6, of July 20th, 1900.—"The Commanding Officer has much pleasure in publishing the following remarks, by Lieutenant-General Sir F. W. E. Forestier-Walker, Commanding Lines of Communication, on the measures taken to frustrate an attempted escape of Boer prisoners of war, at this station on the 12th inst., in which several officers, N.C.O.'s and men of the Battalion were employed.

"Colonel Wyllie acted with promptitude, and his resolute proceedings will have a good effect. His arrangements were good, and appear to have been very well carried out by all concerned."

Under authority, W.O. letter, 1871, dated July 13th, 1900, Major F. A. Hayden was ordered to continue to act as Adjutant of the Battalion, until the return of the Battalion from active service.

Draft.—A draft of 40 men joined from England at Simon's Town, on August 1st.

Move Detachment.—"B" Company, under Lieutenant Hanson, proceeded by march route to Wynberg, in relief of "F" Company.

Draft.—A draft of I sergeant and 82 men arrived at Simon's Town, from England on October 1st.

Promotions.—Captain Johnston was promoted Major, to complete establishment, on October 14th, and Lieutenant Jenkins promoted Captain on September 17th.

Detachment.—"D" Company, under Lieutenant Davis, relieved "B" Company at Wynberg, on October 18th, by march route.

Honorary Colonel.—Lieutenant-Colonel and Hon. Colonel F. C. Wemyss (who formerly commanded the Battalion) was appointed Honorary Colonel of the Battalion, on October 3rd, 1900.

Promotions.—2nd-Lieutenants Dangar, Davis, Martin and E. C. O. Ross were promoted Lieutenants on October 24th, and 2nd-Lieutenants Stonor, Adams, Goddard, Marriner and Glencross were promoted Lieutenants, on November 15th.

Detachment Move.—"H" Company, under Lieutenant Martin, proceeded to Wynberg on December 5th, in relief of "D" Company, by march route.

Command, South Africa.—On November 29th Lord Kitchener of Khartoum was appointed Commander-in-Chief, vice Lord Roberts, who proceeded home to take up command of the Army.

Lord Roberts, while at Cape Town for a few days, before embarking for England, sent a verbal message to Colonel Wyllie, through Colonel Cooper, Base Commandant, to the effect that he had been pleased to receive such satisfactory reports of the Battalion.

1901. Moves.—On January 4th and 5th, 1901, the prisoners of war, in charge of the Battalion, were all placed on board transports in Simon's Bay.

On January 7th the Headquarters, with "C," "D," "E" and "F" Companies, proceeded to Durban Road (12 miles north of Cape Town), and "A" and "B" Companies to Stellenbosch (31 miles). "H" Company rejoined from Wynberg, on January 11th.

On January 14th "F" and "G" Companies proceeded to Malmsbury, under Captain Wayman.

*"F" Company was shortly afterwards provided with horses and "M.I." equipment, and trained as Mounted Infantry.

Regimental Transport. — On January 10th the Battalion was provided with complete 1st Line Regimental Transport, and Lieutenant Glencross was appointed Transport Officer.

Moves.—The Headquarters, with "C," "D," "E," "H," "I" and "K" Companies, returned to the Cape Peninsula, from Durban Road by march route on January 17th, and were encamped at Rondebosch Convalescent Camp till the 22nd, when Headquarters, with "E," "I" and "K" Companies, marched to Wynberg, and were encamped near the Waterworks and below the Hen and Chickens Hill.

"D" Company, under Major Johnston, proceeded the same day, on detachment to Muizenberg, and "C" and "H" Companies, under Captain and Hon. Major Bruce, to the Prince of Wales' Bastion, near Woodstock.

On January 31st "I" Company, under Captain Mayor, proceeded to Hermon (60 miles), and on the same date "K" Company, under Captain Hanson proceeded to Wellington.

On February 6th "G" Company proceeded from Malmsbury to Durbanville, under Lieutenant E. C. O. Ross, by march route, covering the distance, 32 miles, in one march.

About the same date, "B" Company, under Lieutenant Marriner, proceeded from Stellenbosch to Paarl (49 miles) by march route.

^{*} For records of this company, from the above date, until it rejoined the Battalion for embarkation, see pages 118—123.

Transfer to Regular Army.—Lieutenant Dangar was gazetted 2nd-Lieutenant in the 13th Hussars on January 5th.

Moves.—"C" Company, under Captain and Hon. Major Bruce, rejoined Headquarters from Prince of Wales' Bastion, by march route, on February 6th, and on the same day "H" Company, under Lieutenant Martin, moved from Prince of Wales' Bastion, the right-half Company to Fort Mowbray, Rondebosch, and the left-half Company, under Lieutenant Adams, to Fort Malmsbury, near Maitland.

"H" Company rejoined Headquarters at Wynberg on March 4th.

On March 12th Headquarters and "C," "E" and "H" Companies moved by march route to Green Point Camp, Table Bay, two miles from Cape Town, and were quartered in Delhi Lines.

"G" Company rejoined from Durbanville on March 14th, "D" Company from Muizenberg on March 13th, "K" Company from Wellington on March 20th, and "B" Company from Paarl on March 21st.

The above movements were carried out by rail.

Bubonic Plague.—While quartered at Cape Town, the Bubonic Plague, which had become epidemic in the Cape Peninsula during January and February, broke out in the huts, next to Delhi Lines. No case, however, occurred in the Battalion. A battalion rat-catcher was appointed, and was successful in capturing several hundred, but found none infected with plague.

The duties at Green Point were very heavy, upwards of 200 officers, N.C.O.'s and men being frequently on duty each day, either prisoners of war guard, inlying picquet, brigade fire picquet, or Garrison guard.

Move.—About 4 p.m. on April 10th orders were received for five companies of the Battalion to proceed to Beaufort West (339 miles), and accordingly, Headquarters, with "B," "C," "D," "G" and "K" Companies left by rail on April 11th, arriving at Beaufort West early on the morning of April 13th.

"D" Company, under Lieutenant Davis, was dropped at Fraserburg Road (290½ miles) en route.

"H" and "E" Companies remained behind at Green Point, and rejoined Headquarters, on April 25th.

Detachment.—"G" Company, under Lieutenant E. C. O. Ross, proceeded by rail to Krom River (380 miles) on May 22nd.

"A" Company, under Captain Jenkins, rejoined Headquarters from Stellenbosch, on May 24th.

"I" Company, under Captain Mayor, rejoined Headquarters from Hermon on May 26th.

"B," "C," and "E" Companies, under Major Johnston, proceeded to Victoria West Road (419½ miles) on May 28th, and "K" Company, under Lieutenant W. A. Ross, to Richmond Road (452 miles) on the same date.

"C" Company, under Lieutenant Martin, was transferred to De Aar on June 13th.

Transfer to Regular Army.—Lieutenant Glencross was gazetted 2nd-Lieutenant, Lancashire Fusiliers, on May 4th.

Armoured Train.—On April 24th 2 corporals and 26 men were detached as a crew of an armoured train, running between Beaufort West and De Aar, and which was under the command of Sergeant Thompson, Seaforth Highlanders.

The train was transferred to the Eastern Section in July, and the men rejoined Headquarters on August 9th,

in consequence of Sergeant Thompson having been killed in action near Bethesda. The train was then taken over by the Coldstream Guards.

The train was twice in action whilst manned by the Battalion, the first occasion, near the Ganna Blockhouse, on July 21st, and the other time near Bethesda, as above, the only casualty being Sergeant Thompson.

Officers Joined.—2nd-Lieutenants A. L. Dibb and C. R. L. FitzGerald joined from the depôt on May 25th.

Battalion Transport Officer.—Lieutenant E. C. O. Ross was appointed Battalion Transport Officer on June 1st, vice Lieutenant Glencross, who proceeded to join his Regiment on that date.

Major H. J. Johnston was appointed Assistant Staff-Officer to the Officer Commanding Western District, on June 2nd.

Local and Honorary Rank.—The following is an extract from the London Gazette, dated May 21st, 1901:

"The officers of the Militia Regiments and Battalions which have been embodied, in consequence of the war in South Africa, are granted the local rank in the Army of their Militia Regimental rank, from the date of embodiment of such Battalion, or, if promoted, or appointed while embodied, from the date of promotion or appointment, up to the date of disembodiment.

"On disembodiment this local rank is converted into Honorary Army rank."

Transport Officer.—Lieutenant and Quartermaster Hyde was appointed Battalion Transport Officer on July 3rd, vice Lieutenant E. C. O. Ross, appointed Station Staff Officer, Prince Albert Road.

Warrant Rank.—Sergeant-Major L. Bellew was promoted Warrant Officer, from April 1st, 1900.

Transfers to Regular Army.—Lieutenant E. N. M. Martin was gazetted to 5th Lancers, and Lieutenants H. A. Davis and H. B. Goddard to the West Riding Regiment, the appointments being dated July 27th.

Attacks by the enemy.—I: On July 17th, about 9 p.m., five men, under cover of a dark night, approached the sangar on Wellington Hill, overlooking the camp, but were driven off. At the same time a similar attempt was made upon the Blockhouse, at the north entrance of the town, but the enemy made off on being fired upon by our sentry.

Two days before Commandant Malan, with some of his men, had been reported to be in hiding, in the mountains, 16 miles east of Beaufort West.

2.—An attack was made on the detachment, at Richmond Road, where Lieutenant W. A. Ross was in command, on September 13th, at about 9 p.m. The enemy was driven off, after an interchange of heavy firing.

There were no casualties among our men on either occasion.

Promotion.—2nd-Lieutenant P. R. Henry promoted Lieutenant from August 13th, 1901.

Moves.—"D" Company, under Captain Digby, proceeded to Fraserburg Road on September 27th.

"K" Company, under 2nd-Lieutenant W. A. Ross, proceeded from Richmond Road to Prince Albert Road on October 29th.

"D" Company rejoined Headquarters from Fraserburg Road on November 2nd.

"B" Company, under 2nd-Lieutenant Dibb, rejoined Headquarters from Victoria Road on November 6th.

"E" Company, under Captain Jenkins, rejoined Headquarters from Victoria Road on November 11th.

"G" Company, under Lieutenant Marriner, rejoined Headquarters from Kroom River and Ganna on November 26th.

Blockhouse Section, Beaufort West to Victoria Road.—
About November 27th the Battalion took over the Block-

house section—Beaufort West to Victoria Road—and occupied the Blockhouses, as fast as they were built. The equipping and rationing of these Blockhouses entailed a great amount of labour.

Moves.—The Companies went out as follows on subsections:—

"G" Company (Lieut. Marriner), November 27th, 1901.

"B" ,, (Capt. Hanson), December 10th, 1901.

"A" ,, (Capt. Jenkins), December 17th, 1901.

"I" ,, (Lt. Thompson), December 12th, 1901.

"E" ,, (Lt. FitzGerald), December 17th, 1901.

After having completed the occupation of the whole section, and being in possession a fortnight, the whole of the Companies were returned to Beaufort West, on December 31st, being relieved by the 3rd East Surrey Regiment, from the Midland Section.

1902. Detachment.—"B," "E" and "H" Companies, under Captain Hanson, with Lieutenants Dunhill and White, left on January 1st for Fraserburg Village, as escort to 50 wagons, and to remain at Fraserburg on completion of duty.

Command.—Major F. A. Hayden, D.S.O., assumed command of the Battalion, vice Colonel Wyllie, C.B., who proceeded to Wynberg (sick) on January 4th.

Move.—On the same date 3 officers and 150 N.C.O.'s and men ("A," "I" and "G" Companies) were sent at 20 minutes' notice to occupy the intermediate trenches of the 3rd East Surrey Regiment, between Three Sisters and Victoria Road. The men only took one blanket and a waterproof sheet, besides their equipment, as it was understood they would only be out a few days, but they were detained over four weeks without shelter and with scanty rations.

In the meantime Headquarters moved to Carnarvon, taking all stores, etc., with them, and the trench party was not relieved until January 28th. They then proceeded to Victoria Road, by rail, and from there by march route to Carnarvon (92 miles), arriving there in a very ragged condition, but otherwise quite cheerful.

"K" Company rejoined Headquarters from Prince Albert Road on January 11th.

Headquarters and "D" and "K" Companies moved by rail to Victoria Road on January 12th.

"C" Company rejoined Headquarters from De Aar on January 13th.

Headquarters, with "C," "D" and "K" Companies, consisting of 5 officers, 131 warrant officers, N.C.O.'s and men proceeded by march route to Carnarvon (92 miles from the railway, inland), nearly E. to W., on January 13th, and arrived there on January 20th.

"K" Company, under Captain Digby, left Carnarvon on January 21st, as covering party to Blockhouse builders, on Carnarvon to Williston Section.

"A," "I" and "G" Companies rejoined Headquarters from the trenches on February 5th.

"C," "D," "G" and "I" Companies, with Lieutenants FitzGerald, Dibb and Thompson and 143 N.C.O.'s and men proceeded to Beejeslaagte, to join Major Wedgewood's Column, on Blockhouse Head, on February 5th.

Draft.—A draft of 92 N.C.O.'s and men arrived from England on February 8th.

Officers Rejoined.—Captain Mayor and Captain and Hon. Major Moke-Norrie rejoined the Battalion about this time, having been relieved from the Standing Military Court. Moves.—Captain Mayor left Carnaryon to take command of "C" Company, with Major Wedgewood's column.

Captain and Hon. Major Moke-Norrie and 86 N.C.O.'s and men, composed chiefly of those who arrived from England, on February 8th, left on the 11th for Beejeslaagte, to reinforce the Companies on the Blockhouse line.

The N.C.O.'s and men of the 1st Battalion, who had been attached to the Battalion since July 12th, 1900, left Carnarvon on February 26th to join the 1st Battalion, at Warm Baths, Transvaal.

Acting Adjutant.—Lieutenant J. H. L. Thompson assumed the duties of Acting-Adjutant, vice Lieutenant Marriner (sick), on March 8th.

Killed.—Private T. Broadbent, "G" Company, was shot by the enemy, whilst on sentry at a Blockhouse, on the Beejeslaagte Section, on February 13th.

Distribution of Companies.—The Battalion, at Carnarvon, was distributed as follows:—

Headquarters and "A" Company at Carnarvon.

"F" Company (Mounted Infantry) at De Aar.

"H," "E" and "B" Companies at Fraserburg Village.
"C," "D," "G," "I" and "K" Companies were on
Blockhouse Section, from Carnarvon to Williston—120
miles in extent, "C" Company, under Captain Mayor,
remaining as covering party to Royal Engineers Blockhouse builders and working in conjunction with Lord W.
Bentinck's column, which consisted of the 10th Hussars
and Artillery, with other mounted troops.

The remaining companies were distributed at different points along the line, the Headquarters of each Company being as follows:—

- "G" Company—Beejeslaagte.
- "I" Company—Drooze Puts.
- "D" Company—Karree Doorn.
- "K" Company-Klip Kalk.

During the whole time the Battalion occupied the Blockhouses, and also during the building of them, the enemy were hanging around in small parties on adjoining kopjes, and the incessant alarms and constant sniping of the enemy, together with the doubted loyalty of the farmers, involved heavy duties on the men, which they carried out well and cheerfully. Several natives attached to blockhouses were shot, but the only casualty in the Battalion was Private Broadbent, who, as before stated, was shot while on sentry.

The enemy had crept close to the barbed wire, under cover of darkness, thinking to surprise the Blockhouse. Private Broadbent gave the alarm, and was unfortunately shot through the mouth before he could get under cover, inside the Blockhouse.

Orders for Home.—About March 15th a telegram was received from Officer Commanding Western District for the Battalion to proceed home as soon as relieved by the 3rd Battalion Argyll and Sutherland Highlanders.

Moves.—"G" Company rejoined Headquarters at Carnaryon on March 24th, and "A" and "G" Companies left for Victoria Road, on March 26th.

"I" Company rejoined at Carnarvon on March 27th, and left for Victoria Road on the 30th.

"D" and "K" Companies rejoined at Carnarvon on April 3rd.

Headquarters, with "D" and "K" Companies, left Carnarvon, by march route, for Victoria Road, on April 5th, arriving there on the 13th.

"F" Company rejoined at Victoria Road from De Aar on April 10th.

Major Johnston rejoined from duty as Assistant Staff Officer to Officer Commanding Western District, on April 13th.

Embarkation for and Arrival Home.—Headquarters, with "A," "D," "F," "G," "I" and "K" Companies, left Victoria Road, by rail, for Cape Town on April 13th, and after a few days at Green Point, embarked on H.M.T. "Britannic" on April 21st, arriving at Southampton on May 9th, when they entrained and reached Halifax early on the morning of May 10th.

"C" Company arrived at Cape Town the same day as the Battalion sailed, but were too late to go on board. They remained at Green Point Camp until joined by "B," "E" and "H" Companies, from Fraserburg Village. They embarked together on H.M.T. "Canada," and arrived in Halifax on the morning of May 28th.

Reception of the Battalion at Halifax, May 10th.—
The following account is taken from the Halifax
Guardian:—

The special train, with Headquarters and "A," "D," "F," "G," "I" and "K" Companies, reached Halifax at 5.20 a.m., some hours before it was expected. At a late hour the previous night it had been announced that the troops could not possibly arrive before 7 a.m. Consequently, the reception arrangements were very much upset, and there were only a few people at the station.

Colonel Harris, C.B., commanding 33rd Regimental District, arrived shortly, and after some delay the Battalion marched up Horton Street to the Drill Hall, where breakfast was provided by the Reception Committee.

The Battalion was accompanied by a baboon—the pet of the Regiment—which had been picked up in South Africa by Sergeant-Major Bellew some eighteen months previously.

During breakfast the band of the 1st V.B. West Riding

Regiment played selections.

Amongst those at the Drill Hall to welcome the Battalion were Colonel F. C. Wemyss (Honorary Colonel), Archdeacon Brook and the Mayor of Halifax (Alderman Brear). After breakfast, the Battalion marched to the Barracks, headed by the band of the 1st V.B. West Riding Regiment.

Presentation of Medals.—On reaching the Barracks the Battalion was formed up on three sides of a square, and the medals were presented by Colonel Harris, C.B., Commanding 33rd Regimental District.

Colonel Wemyss presented each man with a regimental cane, and addressing the Battalion, said how pleased he was to see them home again, and to hear how well they had done in South Africa, thus keeping the good name which the Regiment had always borne.

The Commanding Officer's Thanks.—Colonel Wyllie, C.B., then thanked the officers, non-commissioned officers and men for the way in which they had kept up the credit of the Regiment, and served their King and country.

Cheers were then given for Colonel Wemyss and Colonel Wyllie, after which the men were marched off, and quickly handed in their equipment, etc., and left the Barracks in civilian attire, after two years and four months' embodiment.

Arrival of the remainder of the Battalion.—"C," "B," "E" and "H" Companies arrived at Halifax on May 28th, and were welcomed in a similar manner to the remainder of the Battalion, Colonel Harris, C.B., pre-

senting the medals, and Colonel Wyllie thanking them for their services, and wishing them good luck in civil life.

APPOINTMENTS HELD BY OFFICERS OF THE BATTALION IN SOUTH AFRICA.

Lieutenant-Colonel and Hon. Colonel A. K. Wyllie, C.B., was Commandant, Simon's Town, from July, 1900—January, 1901; and Commandant, Wynberg, from January, 1901—March, 1901. Also Commandant Prisoners of War Camp for a short period in 1900.

The latter appointment was also held for a short period by Major F. A. Hayden, D.S.O.

Major and Hon. Lieutenant-Colonel E. L. Cordes was Commandant, Prisoners of War Camp, Simon's Town, from October 8th, 1900—July 2nd, 1902.

Major G. E. Moke-Norrie was Commandant, Worcester, from April, 1900—June 1901, and was afterwards on the Standing Military Court for the trial of rebels, etc.

Major Moke-Norrie was Commandant at Worcester at the time of the great "Bond Meeting," which is said to have protracted the war. The meeting had been sanctioned by higher authorities.

Major H. J. Johnston, D.S.O., was Assistant Staff Officer to Officer Commanding Western District, from June 2nd, 1901—April 13th, 1902.

Major Bruce was Station Commandant and Railway Staff Officer, at Wellington, and other stations; also Captains Wayman, Jenkins, Hanson and Mayor, at various stations and for various periods.

Captain E. W. Mayor was also a member of the Standing Military Court, with Major Moke-Norrie.

Hobson, at York, on January 31st, 1903, by Brigadier-General Browne, V.C., Commanding North-Eastern District.

Major and Hon. Lieut.-Col. E. L. Cordes. 1902. Lieut. W. A. Ross. 1902. Lieut. A. White. 1902. Captain E. W. Mayor. 1903. RECORDS OF "F" (MOUNTED INFANTRY) COMPANY, COMMANDED BY CAPTAIN H. H. WAYMAN.

"F" Company, 3rd West Riding Regiment, left the Battalion at Durban Road, in January, 1901, and proceeded to Malmsbury.

In February, 1901, the Company was turned into Mounted Infantry, by order of the Inspector-General of Cape Colony. After three weeks' training in Mounted Infantry duties, the Company, under Captain Wayman and Lieutenant Goddard, was ordered to proceed to Picquetberg Road, by march route, and entrain for De Aar, where they were to join Colonel de Lisle's column.

On arrival at De Aar, it was found that the column had trekked south, after Commandant Kritzinger, making it impossible for the Company to join them. The Company was then taken on the strength of the De Aar Garrison, and utilised for furnishing patrols, outposts, and in bringing in all commandeered horses from the surrounding district.

The next important duties were escorting convoys to neighbouring districts away from the line. On June 9th, 1901, orders were received to escort a convoy of 80 wagons, under command of Capt. Wayman, to Prieska and Kenhardt, the distance, there and back, being 600 miles.

The convoy arrived safely at Kenhardt on June 29th, and left again for De Aar on July 1st, arriving there on July 21st, the duty being performed in a very satisfactory manner.

On July 28th a strong patrol, consisting of all mounted troops in garrison, under Captain Wayman, was sent out, the object being to endeavour to drive a party of the Boers who were in the neighbourhood of Myfontein (25 miles south of De Aar) in a S.E. direction.

The patrol left De Aar at 10 p.m., returning at 7 p.m. the following evening, having successfully accomplished their object and having marched a distance of 60 miles in 21 hours.

Colonel Mackenzie complimented Captain Wayman on the successful manner in which this duty was carried out.

On August 3rd 20 N.C.O.'s and men of the 3rd West Riding Mounted Infantry and 40 N.C.O.'s and men of the 12th Lancers escorted a convoy to Petresville.

The convoy arrived safely as far as Philipstown, but could not proceed further, owing to a commando of Boers, under Commandant Latigan, numbering over 100 strong, threatening Philipstown.

While waiting for reinforcements, the telegraph wires were cut about five miles from Philipstown, and an escort of 3rd West Riding Mounted Infantry accompanied the electricians to repair the wire, and were attacked by the Boers, in two parties, who tried to cut them off. An engagement took place, lasting about one hour, during which we lost two men, captured—Privates Duggan and Lloyd—and 3 horses killed, but managed to get back to Philipstown.

On August 9th the remainder of the company formed part of a mounted force, under Captain Wayman, to reinforce the escort to the convoy and try and get it through to Petresville.

At midnight on August 10th the whole of the escort marched out to attack the Boers, who were holding the Petresville Road at Maccaserfontein. Two of our native scouts, who had been sent out the previous day, were captured, shot and mutilated, and probably told the Boers our movements, as on our arrival at Maccaserfontein the Boers had trekked during the night.

This movement enabled us to take the convoy through to Petresville. Leaving Philipstown at 3 a.m. on the 12th, the convoy made a forced march, and arrived at Petresville on the following morning, missing the burghers, who had been reinforced by Commandant Van de Venter's Commando at Maccaserfontein, by two hours.

After handing over the convoy, the escort and 40 of Geoghan's Scouts were formed into a column, under Captain Wayman, for the purpose of operating against the Commandos of Commandants Latigan and Van de Venter.

After a 10 days' chase, the Boers, between 200 and 300 strong, succeeded in crossing the line, between Krankeil and Pauwpan.

The column remained at Pauwpan for some days, and the various units were then sent to join their various columns, the 3rd West Ridings joining Major Lund's column.

The Company remained with this column for about a week, and then returned to De Aar. With the exception of several reconnaissances, lasting two or three days each time, nothing of note occurred until September 29th, when Captain Wayman received a sudden order to proceed to Richmond, to take command of a party of the 9th and 12th Lancers, who were operating against Commandant Malan.

On September 30th the Company was ordered to Richmond, under Lieutenant Thompson, 1st Brabant's Horse, to work in conjunction with Captain Wayman, who took command of the combined force operating against Commandants Malan and Latigan, who had joined their commandos.

After several skirmishes near Murraysburg, an action was fought at Tygers Hock, near Nelsport, on October

15th, which resulted in two of the enemy being wounded and several horses being killed. The enemy then retired S.E.

Continuing to follow them, a second engagement took place at Swartbosch, lasting about two hours; the Boers were on a kopje overlooking a drift, which we had to cross, and they waited until our carts were in the drift before opening fire.

The fighting was very sharp, but we managed to get round their position and into their rear, when darkness coming on, the burghers vacated their position.

The Boers lost three men killed, and several were known to be wounded, and we also captured 10 of their horses, with saddlery, ammunition, etc. The Company had four men wounded and nine horses killed.

The Company returned to De Aar on November 7th. On November 10th 20 N.C.O's and men of the Company, under Lieutenant Dunhill, and the 86th Battery Royal Field Artillery, under Major Stewart, escorted a convoy to Philipstown. After handing over the convoy, they searched all farms in the district for arms, etc., returning to De Aar on November 19th.

On November 29th the Company joined Colonel Hunter-Weston's column, operating against Naude. After two days' skirmishing, the Commando was supposed to have been split up, forty Boers being supposed to have crossed the railway line.

The Company was detached with thirty Royal Field Artillery and half a squadron of French's Scouts and sent after this party.

We got in touch with the enemy at 6.30 p.m. on December 5th, at Kalkwahl and found the whole of the Commando was there, outnumbering us by about 20 men.

We attacked the Boer position, but the burghers vacated it at once, leaving some ammunition, saddlery, coffee and meat.

They then took up an impregnable position, about a mile away, which was too strong for us to attack.

During the night the Boers retired, and we were recalled by despatch, and congratulated by General Sir H. Settle on our work.

In December, 1901, the Company was strengthened by 45 volunteers from Headquarters, and "C" Company, then at De Aar, and after a few days' training the whole Company and two squadrons of Border Scouts formed a column, operating in conjunction with Colonel Lord W. Bentinck's Column against Commandants Kritzinger and Wessels.

Although the Company did not see any fighting, they took part in the driving, which resulted in Commandant Kritzinger being wounded and captured.

After this the Company moved to Britstown, where we picked up and escorted a convoy to Prieska, arriving there on Christmas Day, 1901.

On the return journey to De Aar an engagement was fought with Commandant Conroy at Roodeport Nek.

The Boers were driven off without any loss to ourselves. On January 18th, 1902, the Company and "B" Squadron 12th Lancers and two troops 5th Lancers, and three Companies of 3rd Queen's (Royal West Surrey) Regiment escorted a large convoy, composed of 200 wagons, to Prieska, arriving there on January 26th.

The same night the escort, under Colonel Clarke, D.S.O., Commanding North-Western District, left Prieska to attack Commandant Conroy's Commando.

After a two days' trek we discovered the Boers, occupying a range of hills round Halpan. A sharp engagement

took place, lasting from 6 a.m. to 9.30 a.m., but the Boers could not be dislodged.

Our casualties were one man killed and seven wounded and one captured (all 12th Lancers). The escort then returned to Prieska, and from there to De Aar, arriving on February 9th.

The Company then joined Major Wormald's column, and took part in all his operations until April 8th, when we received orders to return to De Aar and hand in horses, saddlery, etc., and rejoin Headquarters at Victoria West Road.

To-Captain Wayman.

The following telegram has been received by me from General Settle:—

"December 4th, S. 424. Please send following at once, by mounted messenger, to Captain Wayman, who was at Kartkop farm, N.N.E. of you, about 36 miles." Begins:

"You and your men have done very well. Please tell your men so. Return now by nearest route to line, either to Britstown or Potfontein, as you think best, as it is useless to pursue further, and you are not strong enough to engage." Message ends.

Royal Message to the Militia.

His Majesty the King has been pleased to order the following gracious message to the Militia to be promulgated for the information of the whole Army:—

"At this time, when the Militia is to be asked to undertake new duties and fresh liabilities, I take the opportunity of expressing to the Force my keen appreciation of its services in the past.

"In peace and in war, the Militia has never been asked in vain to make sacrifices for the good of the country.

"The devotion to duty which has ever distinguished the Militia will, I am convinced, continue to be shown by the officers and men of the Force, whatever calls may be made on them.

"I express my special thanks for past services to those battalions and other portions of the Militia to which, to my great regret, no place can be assigned in the new organization.

"I desire that this message may be promulgated for the information of the whole Army."


